Is your business considered an Essential Industry?

NEW Protocol for Essential Business: At this time (3/25/2020), North Carolina is not under a shelter-inplace order. However, during times of emergency, local and state government does have the authority to impose restrictions. To continue operations through a restriction or curfew, your business must apply for Re-Entry Certification. The N.C. Business Emergency Operations Center offers <u>these steps</u> to complete that request for certification. For guidance on how U.S. Homeland Security defines "Essential Critical Infrastructure Workers," <u>check here</u>. Businesses should email <u>beoc@ncdps.gov</u> with the following:

Do you need to file an Unemployment Insurance claim?

If you have lost your job or been laid off, <u>file an Unemployment Insurance (UI) claim</u>. New changes to the state's unemployment system have occurred due to the current impacts of the COVID-19 coronavirus in North Carolina. <u>COVID-19 specific information is here</u>. It has information for both employers and people seeking unemployment benefits.

Are state and federal agencies offering any payment relief or extended payment deadlines to me or my business?

Federal Coronavirus Tax Relief

The U.S. Treasury Department and Internal Revenue Service have announced that the federal income tax filing due date is automatically extended from April 15, 2020, to July 15, 2020. Taxpayers can also defer federal income tax payments due on April 15, 2020, to July 15, 2020, without penalties and interest, regardless of the amount owed. This deferment applies to all taxpayers, including individuals, trusts and estates, corporations and other non-corporate tax filers as well as those who pay self-employment tax.

N.C. Department of Revenue Special Penalty Relief

The N.C. Department of Revenue recently announced that they will extend the April 15 tax filing deadline to July 15 for individual, corporate, and franchise taxes to mirror the announced deadline change from the Internal Revenue Service. In addition to the filing extension, the NCDOR <u>will not charge penalties</u> for those filing and paying their taxes after April 15, as long as they file and pay their tax before the updated July 15 deadline.
