# **POPULATION & DEMOGRAPHICS**

All population figures taken from US Census Quick Facts

## Population % Change (2020 -2023):

The difference between an area's population in 2020 and 2023, expressed as a percentage of the population in 2020.

## % Population, White; Black or African American; Asian

The percentage of the total population within each state that identifies as White, Black or African American, or Asian.

#### % Population, Hispanic

The percentage of the total population within each state that identifies as Hispanic. Hispanic origin is considered separately from race and not categorized as such.

#### % Population, Foreign Born

The percentage of the total population within each state that includes anyone who was not a US citizen at birth. This includes respondents who indicated they were a US citizen by naturalization or not a US citizen.

#### **Net Migration**

Calculated by taking the net difference of in-migration and out-migration of domestic and international movers.

#### **Net Migration Rank**

Ranking of states from highest to lowest net migration total, where 1 reflects the highest net migration and 50 reflects the lowest net migration rate. Ranking calculated by the EDPNC.

#### **Labor Force**

Labor force encompasses all employed individuals as well as individuals seeking jobs.

#### Projected Labor Force (2028)

Projected labor force through 2028 using several datasets from The Bureau of Labor Statistics' Employment Projections.

# **Labor Force - Manufacturing**

Labor force of those employed in or looking for employment within the Manufacturing industry, defined by NAICS codes 31, 32, and 33.

#### **Labor Force - Financial Services**

Labor force of those employed in or looking for employment within the Finance and Insurance industry, defined by NAICS codes 52.

#### Labor Force - Life Sciences

Labor force of those employed or looking for employment within a custom grouping of NAICS codes representing the Life Sciences sector, including 311221, 311224, 325193, 325311, 325312, 325314, 325320, 325411, 325412, 325413, 325414, 334510, 334516, 334517, 339112, 339113, 339114, 541714, and 621511.

#### Labor Force - Tech & Innovation

Labor force of those employed in or looking for employment within the Computer and Mathematical occupation group, defined by SOC code 15-0000.

#### % Population with a Bachelor's degree+

The percentage of North Carolina residents aged 25 and older with a Bachelors, Masters or Postdoctoral degree.

# % Population with Associate's degree+

The percentage of North Carolina residents aged 25 and older with an Associate's, Bachelors, Masters, or Postdoctoral degree.

## **BUSINESS COSTS & ECONOMY**

#### **Corporate Tax Rate**

An income tax is levied on the net taxable income of all corporations chartered in North Carolina or doing business in North Carolina, unless they are specifically exempt from tax under G.S. 105-130.11. Net taxable income shall be the same as taxable income as defined in the Internal Revenue Code in effect for the income year for which the returns are to be filed, subject to the adjustments provided in G.S. 105-130.5.

#### Personal Income Tax Rate

Individual income tax (or personal income tax) is a tax levied on the wages, salaries, dividends, interest, and other income a person earns throughout the year. Rates listed for states with a tiered income bracket system reflects the tax rate for the highest income bracket.

#### **Sales Tax Rate**

The percentage at which a government imposes a tax on the retail sale of goods and certain services, typically paid by the consumer at the point of purchase. Rate includes the state tax rate combined with a population-weighted average of local sales taxes to give a sense of the average combined sales tax rate for each state.

#### **GDP**

Total market value of the final goods and services produced within North Carolina in a year. Obtained using Real GDP (Millions of chained (2017) dollars) from 2023 Third Quarter, Seasonally adjusted at Annual rates.

Ranking of states from highest to lowest GDP, where 1 reflects the highest net migration and 50 reflects the lowest net migration rate. Ranking calculated by the EDPNC.

# **QUALITY OF LIFE**

## **Cost of Living Index**

Cost of Living Index measures relative price levels for consumer goods and services in participating areas. The average for all participating places, both metropolitan and nonmetropolitan, equals 100, and each participant's index is read as a percentage of the average for all places. A score below 100 means that a location has a lower cost of living on average than the nation.

#### Average Monthly Utility Costs

Average cost of common residential household utility prices. Costs include electricity, cable/internet, Sewer/Garbage/Recycling, Gas, Streaming, and Water.
