





The State Trade Expansion Program (STEP) is specifically designed to help small businesses in North Carolina fund costs associated with international trade. As a qualifying participant in STEP, you can be reimbursed for thousands of dollars of expenses that your business would normally have to pay outof-pocket. Because it's grant money, you are under no obligation to repay any amount. In other words, the cost of doing business internationally becomes much less costly.

QUALIFYING EXPORTERS ARE ELIGIBLE FOR UP TO \$12,000 IN REIMBURSEMENTS FOR BUSINESS-BUILDING ACTIVITIES SUCH AS:

\$3,000

for eligible travel associated with coexhibiting in an EDPNC booth at a tradeshow

\$8,000

for booth costs for exhibiting at a qualifying trade show

for qualifying export services and marketing media which aid in reaching foreign markets

for qualifying website translation and e-commerce fees

for qualifying EXIM credit insurance fees

for qualifying international marketing lead subscriptions

for qualifying US Commercial Service Export Services



This is a competitive grant for new and past STEP users. We look at a company's past results (completed evaluations and follow up surveys) using the grant and plans to succeed in the future. Once approved, there is a set amount put aside for exporter reimbursement (available only until September 29, 2026). Make sure you receive what the SBA and State of North Carolina want to give you. Eligible companies must: be organized or incorporated in the US; operate in the state of North Carolina; meet the SBA's size standards for a Small Business Concern (typically 500 employees or less); have been in business for no less than 1 year; be in good standing with the federal government (have not been debarred); be an export-ready US company seeking to export goods or services of US origin or have at least 51% US content; and have access to sufficient resources to bear the costs associated with trade.
